- **Communication and Supervision:** Maintain open communication with supervisors by promptly sharing concerns and updates regarding client cases.
- **Documentation and Evaluation:** Keep meticulous records and documentation of client interactions and services provided. Implement program evaluations to assess and enhance service effectiveness continually.
- **Mobile Advocacy:** Facilitate Mobile Advocacy efforts by meeting clients in community settings, workplaces, or other secure locations as needed. Accompany clients to appointments to provide support and ensure access to necessary services.
